- ⇒ After the lunch, Mr.Milios presented his survey about refugees in Greece and informed the participants about them. He analyzed the present situation of refugees.
- ⇒ All the participants agreed to determine the adult education organizations in order to disseminate the project. They have to obtain the database for women refugees' education organizations.
- ⇒ The partners determined to send the coordinator the necessary legal documents required by Turkish National Agency since the coordinator would prepare and submit the Interim Report. They agreed sending the coordinator all the eligible documents (between the project start date and 31st of May) before the Interim Report submission date.
- ⇒ Mr. İlin presented financial management plan to discuss financial issues with all partners.
- ⇒ The discussion was carried out by the difficulties in the implementation, and how each partner overcame them, and the obligations were confirmed by each partner until the next meeting.
